



On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the Council:

The Annual Return was not accurately completed before submission for review:

- Section 1, Box 10 is inconsistent with the balance published by the Public Works Loan Board. The figure in Box 10 should read £673. Please ensure that this is used in the comparative figures on the 2015/16 Annual Return
- The Council has confirmed that the figure included in Box 4 (staff costs) is not paid to a member of staff. In future years, please include these payments within Box 6 (other payments). Please ensure that the restated amounts are used in the comparative figures on the 2015/16 Annual Return
